## Minutes of Meeting of Board of Directors of Deerfield Village Property Owners' Association, Inc.

During the reports of officers, Mike K. (Treasurer) presented the September financial report. All items look to be in line with the budget and our bills are paid.

Under old business, Bill S. will be sending out reminders to everyone about the Tree Planting on Saturday, October 23. A sign will be put in the kiosk. Janie will also send out a notice of the Adopt-A-Spot cleanup on November 13the and an email about the Community Wellness Walk-Through on October 16<sup>th</sup>. Signs for these two events will be posted at the kiosk.

Under new business, Bill (Streets & Grounds) asked that Guidelines for solar panels be considered. Several suggestions: work must be done by a licensed contractor, panels are to be installed on the roof and must be flat against the roof, and the request must be approved before installation. A draft will be worked on and be discussed at the November meeting. Bill also noted that he would be willing to address the continuing care of our new trees to include the removal of the stakes and cages from the more mature. He will also investigate how long the trunk protectors should stay on. The deer have damaged several trees recently! Janie apologized for removing the protectors on the advice of Zach with Cacapon Institute. Zach doesn't know our deer!

Under Good and Welfare, the November 2, 2021, board meeting was discussed as possibly being at Janie McSwain's home. There being no further business to come before the board, upon a motion made, seconded, and unanimously approved, the meeting was adjourned at 7:44 PM.
